As an independent service the scope of the services was to look into whether it was a design issue, electrical issue, contractor issue, etc. They think the problem with the controls has been fixed. This is going to be a back charge to the Manufacturer. During the cooling season, they will be asked to come back to check that system and sign off on it as well.

Construction Manager's Report Oswegatchie School: O & G

#### 1. Monthly Progress Report #16

Mr. Kotait showed slides of the progress at Oswegatchie Elementary School. The first slide showed the Main Entrance and the sidewalks and landscaping that have been done. The second slide showed the site work; preparation of the sub base, swales, site lights on the main road, the next slide showed the main mechanical room, the floors have been sealed and the cleaning equipment is there. The penthouses were next and the mechanical equipment and the energy recovery units in those areas were shown. The MCER (Main Communications Equipment Room) was shown which houses the phone system, receivers, cameras, and buzzer systems. The classrooms have the interactiveboards, and the white and tackboards and have the wireless sound systems with speakers in the ceiling so the teacher can speak into a microphone and be heard throughout the classroom. Display cases in the front entrance have been installed and the stone floor is coming tomorrow. Mr. Kotait then went over the material delivery schedule. Movers will be there on June 29<sup>th</sup>, abatement will start on July 6<sup>th</sup>, and will be followed by the demolition so the bus loop can be started, the HVAC is ongoing, the security system is finished, the lights will be done at the end of this month, the fire alarm test will be done on June 22<sup>nd</sup>, the elevator passed the inspection, and the kitchen passed. There are sufficient grassy areas for the play areas.

It was suggested that the next regular School Building Committee meeting and walkthrough be held at the new Oswegatchie Elementary School in July.

## 2. Discussion and action on the CEA Change order request #00010 to add a light fixture to the mid landing of stair #4 in the amount of \$1,285.58.

Mr. Kotait explained that the mid landing is too dark. It was recommended that the new light fixture be considered part of the emergency lighting.

Mr. Allen showed slides of the progress at Great Neck School. Slides were shown of the foundation A & B, the sanitary and storm systems which were approved yesterday, the water treatment system is working well. The underground plumbing "A" was also shown. The lower detection basin was shown. The structural steel is ready to go. The crane will be coming next week. The geothermal is about 1/3 done with 32 wells drilled. The drill rig # 1 and #2 were shown. Sedimentation traps were shown near the access road. The pumping trenches were also shown. The weir tank, clarifier, and dissipater pad were shown. The Frac tanks and filters were shown.

#### 1. Discussion and possible action on bid package 2.16 Security

Mr. Schilling reported that they received three bids on Bid Package #2.16-Security Systems. The bid specifications had been changed to be compatible with the security systems already at Oswegatchie and Quaker Hill schools. The lowest responsible bidder was Electrical Energy Systems Voice/Data in the amount of \$207,000.
